OUR REPUBLIC WAS FOUNDED ON NATURAL LAW!

1776 – DECLARATION OF INDEPENDENCE - We hold these truths to be self-evident, that all men are created equal, that they are endowed by their Creator with certain unalienable Rights, that among these are Life, Liberty and the pursuit of Happiness.--That to secure these rights, Governments are instituted among Men, deriving their just powers from the consent of the governed, --That whenever any Form of Government becomes destructive of these ends, it is the Right of the People to alter or to abolish it, and to institute new servants!

1787 – US CONSTITUTION - PREAMBLE: We the people of the United States, in order to (1) form a more perfect union, (2) establish justice, (3) insure domestic tranquility, (4) provide for the common defense, (5) promote the general welfare, and (6) secure the blessings of liberty to ourselves and our posterity, do **ORDAIN AND ESTABLISH** this Constitution for the United States of America.

1791 – BILL OF RIGHTS: THE Conventions of a number of the States, having at the time of their adopting the Constitution, expressed a desire, in order **to prevent misconstruction or abuse of its powers, that further declaratory and restrictive clauses should be added:** And as extending the ground of public confidence in the Government, will best ensure the beneficent ends of its institution.

AMENDMENT X: The powers not delegated to the United States by the Constitution, nor prohibited by it to the States, are reserved to the states respectively, or to the people.

1822 – TREATY OF VERONA - The British Monarch and Pope secretly agree to undermine the American System of government via the Treaty of Verona. The British Monarch breaches the Treaty of Ghent and both the Pope and the King secretly breach their trust as International Trustees. They set out on a covert action and issued Letters of Marque and Reprisal [*Marked as an enemy in wartime*] **to the Members of the Bar Associations, allowing them to Act as Foreign Agents on American Soil and as privateers free to plunder American commerce.**

Letters of marque and reprisal are commissions or warrants issued to someone to commit what would otherwise be acts of piracy.

CONGRESSIONAL RECORD - SENATE. 64th CONGRESS, 1st SESSION VOLUME 53, PART 7 Page 6781 25 April 1916: “I wish to put in the RECORD the secret treaty of Verona of November 22, 1822, showing what this ancient conflict is between the rule of the few and the rule of the many. I wish to call the attention of the Senate to this treaty because it is the threat of this treaty which was the basis of the Monroe doctrine. It throws a powerful white light upon the conflict between monarchical government and government by the people. The Holy Alliance under the influence of Metternich, the Premier of Austria, in 1822, issued this remarkable secret document:”

RESPONSE TO THE TREATY OF VERONA!

1819 AMENDMENT XIII: - Because of British Bar Lawyers operating in our courts and Congress were working to undermine our Common Law our founding fathers introduced and past the 13th Amendment which states:

*“If any citizen of the United States shall accept, claim, receive, or retain any title of **nobility or honour**. ... from any emperor, king, prince, or foreign power, such person shall cease to be a citizen of the United States, and shall be incapable of holding any office of trust or profit under them, ...”*

1823 – THE MONROE DOCTRINE – In response to the Treaty of Verona Monroe followed Adams's advice and laid out an independent course for the United States, declaring four major points in his December 2, 1823, address to Congress. He made four basic statements:

- 1) The United States would not get involved in European affairs.
- 2) The United States would not interfere with existing European colonies in the Western Hemisphere.
- 3) No other nation could form a new colony in the Western Hemisphere.

- 4) If a European nation tried to control or interfere with a nation in the Western Hemisphere, the United States would view it as a hostile act against this nation.

In his Monroe Doctrine, he said that the peoples of the West "are henceforth not to be considered as subjects for future colonization by any European powers."

TREASON BY ENEMIES FOREIGN AND DOMESTIC!

1835 - President Jackson's attempted assassination on January 30, 1835, he was a staunch opponent of central banking, particularly the 2nd Bank of the United States - and central banking has long been an Illuminati stronghold.

1841 - President William Henry Harrison obstructed the Illuminati and was assassinated via arsenic poisoning.

1850 - President Zachary Taylor obstructed the Illuminati assassinated arsenic poisoning.

1857 - President James Buchanan obstructed the Illuminati and survived attempted assassination poisoned, but he survived.

1865 - President Lincoln financed the War with Greenbacks refusing loan from bankers and was assassinated.

1871 – **ORGANIC ACT OF 1871** - Created a foreign state within a state within a city forming a corporation called THE UNITED STATES Inc., owned by foreign interests, moved in and shoved the original Constitution into a dustbin. In an act of high treason, the 41st Congress acted without constitutional authority, an act of fraud, conspiracy and subversion against the United States of America attempting to depose our covenant with our creator and thereby establishing a totalitarian government unaccountable to We the Sovereign People, under foreign control, behind which the conspiratorial erosion of our Constitution began. This transformed our Unalienable Rights to civil rights, our Republic to a democracy, the United States to a corporation, and the Laws of Nature's God to civil and criminal laws which have their roots in Babylon. This placed the United States under fiction of law and as long as the People believe the fiction to be law, it is!

1876 – **THE ORIGINAL 13th AMENDMENT**: The treasonous British BAR and their "Esquires", minions of the NWO, manipulated the constitutionally ignorant Congress to conspired to supplant the Law in exchange for money and power, placing themselves in positions of honor that was forbidden them by the original 13th Amendment, ratified in 1819 and concealed in 1876, which carries an enforceable strict penalty, i.e., "inability to hold office" and "loss of citizenship" for holding the title of honor called "Esquire". The Original 13th Amendment stated –

"If any citizen of the United States shall accept, claim, receive, or retain any title of nobility or honour, ... from any emperor, king, prince, or

foreign power, such person shall cease to be a citizen of the United States, and shall be incapable of holding any office of trust or profit under them,...

1878 – SEVENTY-FIVE LAWYERS ESTABLISH: The American BAR Association! (ABA) was founded on August 21, 1878. In an act of high treason, 100 BAR lawyers from twenty-one states and the District of Columbia met in Saratoga Springs, New York, to establish the American Bar Association (ABA), the minions of the “new order of the ages.” Since that first meeting, the ABA has worked in the shadows infiltrating our government, our courts, our churches, our institutions and our media; demoralizing our children all in an effort to expunge our common law and replace it with civil law a/k/a Babylonian law, Justinian law, or Roman Law.

The NBA legal profession as we know it today barely existed at that time. Today the ABA is one of the world’s largest professional organizations, with nearly 400,000 members and more than 3,500 entities. Today the ABA holds a monopoly over the minds of the federal and states judiciaries and attorneys that practice law in our courts. Law schools are nationally accredited by the American Bar Association (ABA), and graduates of these schools may generally sit for the bar exam in any state. There are 204 ABA accredited law schools. There are 31 law schools that have not been approved by the American Bar Association. Some states permit graduates of these schools to take the bar examination or will admit to their bars a graduate of a non-ABA-approved law school who has been admitted to the bar of another state. Most states do not.

THE ABA SCHOOLS, in an act of treason, teach that “In law”, common law is the body of law derived from judicial decisions of courts and similar tribunals. Claiming that the defining characteristic of “common law” is that it arises as precedent.

Whereas Common Law is “NOT” precedent or legislated law, where one size fits all, it is NOT civil law. Common Law a/k/a Natural Law is governed by “maxims”, written in the heart. **Rom 2:14-15** *“For when the Gentiles, which have not the law, do by nature the things contained in the law, these, having not the law, are a law unto themselves: Which show the work of the law written in their hearts, their conscience also bearing witness, and their thoughts the mean while accusing or else excusing one another;”*

Today, with almost a half a million BAR members, 80,000 of them are working in Washington DC. They have perverted the rule of law, deprived We the Sovereign People of due process and have supplanted our Article III courts with jurisdictions unknown.

1881 - President James Garfield assassinated.

1901 - The Skull and Bones became firmly entrenched and controlled the U.S. Republic they are nothing more than a political assassination hit team against those United States politicians who do not fall in line with the House of Rothschild’s plans for a blood elitist domination and control over the world’s economy.

1901 - President William McKinley Jr. assassinated

President Theodor Roosevelt is quoted with saying, *"Behind the ostensible government sits enthroned an invisible government owing no allegiance and acknowledging no responsibility to the people. To destroy this invisible government, to befool the unholy alliance between corrupt business and corrupt politics is the first task of the statesmanship of the day."*

1910 – CONSPIRACY AT JEKYLL ISLAND: In November 1910 in an act of high treason, six men – Nelson Aldrich, Abram Andrew, Henry Davison, Arthur Shelton, Frank Vanderlip and Paul Warburg – met at the Jekyll Island Club, off the coast of Georgia, to write a plan to reform the nation’s banking system. The meeting and its purpose were closely guarded secrets, and participants did not admit that the meeting occurred until the 1930s. But, the plan written on Jekyll Island laid a foundation for what would eventually be the Federal Reserve System.

1913 – FEDERAL RESERVE ACT: The unconstitutional Federal Reserve Banking Act gave control of America’s economy to a private corporation owned by foreign bankers who answer to no one and regulate the value of worthless notes of debt called the dollar, robbed We the People of our gold and bankrupted America. A conspiracy among Paul Warburg, Edward Mandell House, Woodrow Wilson, J.P. Morgan, Benjamin Strong, Otto Kahn, the Rockefeller family, the Rothschild family, and other European and American bankers which resulted in the founding of the U.S. Federal Reserve System which resulted in a takeover of the US economy, on behalf of the oligarchs.

The Federal Reserve Act of 1913 defies Article 1, Section 8, Paragraph 5 of the United States Constitution by creating a "central bank of issue" for the United States. World War I, the Agricultural Depression of 1920, the Great Depression of 1929 were brought about by international banking interests in order to profit from conflict and economic instability.

1913 – 16th AMENDMENT [*was never ratified*]

The Sixteenth Amendment which only appears to create an income tax, an act of extortion and a sponsor of debtor’s prisons via a slave tax, in direct violation of the Constitution Article I Section 9 Clause 5. “No capitation, or other direct, tax shall be laid, unless in proportion to the census or enumeration herein before directed to be taken.”

1913 – 17th AMENDMENT: The Seventeenth Amendment destroyed the checks and balance of power in violation of the Constitution Article V, which states, “no state, without its consent, shall be deprived of its equal suffrage in the Senate.” The 17th Amendment removed the States representation in Washington giving the Senate to the People who already had representation in congress thereby “depriving states of its equal suffrage.”

1921 - The Council on Foreign Relations founded by President Woodrow Wilson's chief advisor, Edward Mandell House, in order to destroy freedom and independence in the United States. The CFR is the American Branch of a society which originated in England, and which believes that national boundaries should be obliterated, and a one-world rule established." House, as a Marxist hoped to create a socialist society in the United States. Key financing for the Council came from the Rockefeller and Carnegie Foundations in the 1920s, and in the 1940s.

Roosevelt invited CFR members to take over important positions in the State Department, known to us today as the Deep State having retained domination until today. Since the council's founding in 1921, 21 secretaries of defense or war, 19 secretaries of the treasury, 17 secretaries of state, and 15 CIA directors have hailed from the Council on Foreign Relations.

1923 - President Warren Harding assassinated by poison

1929 - The main headquarters of the CFR is at the corner of Park Avenue and 68th Street in New York City. The building was donated to the Council by the Rockefeller family in 1929 and the organization's main goal remains to destroy the freedom and independence of the United States. David Rockefeller was Chairman of its Board of Directors until his death 2017.

1922 – BAR ATTEMPT TO ABOLISH GRAND JURIES: In March 1922, in an act of high treason, the New York County Association of the Criminal BAR announced that it planned a vigorous state wide campaign to abolish the Grand Jury institution. Former district attorney Robert Elder called upon public prosecutors to take the initiative in replacing what he called the “**inefficiency, ignorance and traditional bias**” of grand jurors, and Judge Thomas Crain of New York supported the movement.

Testifying before the Committee of Law Enforcement of the American Bar Association, he observed that “a judge or some other man learned in statutes should participate in grand jury hearings.” In Minnesota, attorney Paul J. Thompson urged his state to adopt the Wisconsin system of prosecution upon the order of a district attorney.

In 1922, Judge Roscoe Pound and Felix Frankfurter conducted a survey of criminal justice in Cleveland and added the weight of expert testimony to those who sought to eliminate the use of grand juries. Pound and Frankfurter reported that “*juries were inefficient and unnecessary,*” since trial courts (politically driven men) were quite capable of protecting Americans against executive tyranny.

1933 - Retired Marine Corps Major General Smedley Butler asserted that wealthy businessmen were plotting to create a fascist veterans' organization with Butler as its leader and use it in a coup d'état to overthrow President Franklin D. Roosevelt.

1933 – WAR POWERS ACT - The War Powers Act, also referred to as the “War Powers Resolution,” or the “War Powers Resolution of 1973,” is a federal law that governs the president's power to bring the U.S. into an armed conflict without first obtaining authorization from Congress as required under Article I Section 8 Clause 11.

1933 – EMERGENCY BANKING ACT - The United States Federal Government has been dissolved by the Emergency Banking Act on March 9, 1933.

1933 – GOLD CONFISCATION - United States Gold Confiscation Labeled Executive Order 6102, President Franklin Roosevelt signed on a law on April 5, 1933 “forbidding the hoarding of gold coin, gold bullion, and gold certificates within the continental United States.”

1933 –FEDERAL RESERVE - An astounding exposure Congressman McFadden on the Federal Reserve Corporation Remarks in Congress, 1934; On May 23, 1933, Congressman, Louis T. McFadden, brought formal charges against the Board of Governors of the Federal Reserve Bank system, The Comptroller of the Currency and the Secretary of United States Treasury for numerous criminal acts, including but not limited to, conspiracy, fraud, unlawful conversion, and treason. “*Mr. Chairman, we have in this Country one of the most corrupt institutions the world has ever known. I refer to the Federal Reserve Board and the Federal Reserve Banks, hereinafter called the Fed. The United States has been ransacked and pillaged. Our structures have been gutted and only the walls are left standing.*” The petition for Articles of Impeachment was thereafter referred to the Judiciary Committee and has yet to be acted on.

1934 – RULES ENABLING ACT via the BAR working in Congress, gave the United States Supreme Court the authority to write their own rules.

1936 - Congressman, Louis T. McFadden assassinated

1938 – US SUPREME COURT BETRAYED THE PEOPLE: via the BAR working in our Courts. On September 16, 1938, a day that will live in infamy, eight of nine men, one resigned, whereas the US Supreme Court, steered by the subversive ABA, authored the Federal Rules of Civil Procedure replacing the rules of Common Law. Particularly Rule 2 that abrogated Common Law and replaced it with civil law, thereby committing an act of Treason, deserving of the ultimate penalty Natural Law has to offer. Their evil, reprehensible covert exploit is responsible for multi-millions of deaths and destroyed lives.

According to the Federal Judicial Center, in 1938, pursuant to its alleged authority under the Rules Enabling Act of 1934, the Supreme Court enacted uniform “rules” of procedure for the federal courts. Among the changes wrought by the “rules” where the Supreme Court claimed that common-law rules have brought about injustice was Rule 2 which states, “*The elimination of the federal courts’ separate jurisdiction over suits in equity. Under the new rules, suits in equity and suits at common law were grouped together under the term civil action.*” This betrayal brought America under civil law, a/k/a Babylonian or Roman law. Which is repugnant to the Constitution and thereby null and void. But as long as the People believe that civil law is the Law of the Land! It is!!!

1941 - President Roosevelt played a critical role in the staging and propaganda of World War II, which brought tremendous wealth and power to the Cabal.

1944 – BRETTON WOODS AGREEMENT: The United States surrendered to centralized banking system. The prevailing economic system of the world is based on the Bretton Woods Agreement, which was established after the second world war. While all the countries thought that the economies of the world would boost and the people would have more money in their hands, little did they know that it was just a plan to destroy the currencies of the world to make the dollar the currency anchor of the world.

1945 – Truman became President and was one of the most active and enthusiastic Masonic presidents, was a member of Illuminati groups the Skull and Bones, and the Council on Foreign Relations.

Former CFR member Rear Admiral Chester Ward said: *"The most powerful clique in these elitist groups have one objective in common -- they want to bring about the surrender of the sovereignty of the national independence of the United States. A second clique of international members in the CFR comprises the Wall Street international bankers and their key agents. Primarily, they want the world banking monopoly from whatever power ends up in the control of global government."*

Dan Smoot, a former member of the FBI said: *"The ultimate aim of the CFR is to create a one--world socialist system, and to make the U.S. an official part of it."*

1947 – CIA & NSA: Creation of a National police state surveillance grid

1948 – UNITED NATIONS: The United Nations (UN) is an intergovernmental organization that promotes international co-operation to create and maintain international order. The UN was established in an effort to establish a "One World Government." The UN also supports population control by supporting government programs that promote forced-abortions and coercive sterilizations.

1950 – CONGRESSIONAL REPORT ON THE NATIONAL LAWYERS GUILD: Revealed an ABA communist plot.

1954 - INTERNAL REVENUE CODE – Written by the BAR controlled Congress

1954 – THE DODD REPORT - Norman Dodd investigator for the Reece Committee on Foundations concerning un-American activities in government; the findings of the Reece Committee were very revealing. It was found out that the big foundations were promoting internationalism and collectivism. By their subversive funding activities they posed a clear threat to our American Republic and way of life of American people. The foundations were monumental in shaping the education and foreign policy of the United States and not only this but the foundations had their presence in all areas of society and in some areas had become more powerful than the federal government. Research and experimental stations were established at selected Universities, notably Columbia, Stanford, and Chicago. Here some of the worst mischief in recent education was born. In these Rockefeller and Carnegie established a corrupt American education. Here foundations nurtured some of the most ardent academic advocates of upsetting the American system and supplanting it with a Socialist state.

1961 - President Dwight Eisenhower gave the nation a dire warning about what he described as a threat to our Republican government. He called it the military-industrial complex, a formidable union of defense contractors and the armed forces

1963 PRESIDENT KENNEDY ASSASSINATED – Just weeks before he said, *"A revolution is coming – a revolution which will be peaceful if we are wise enough; compassionate if we care enough; successful if we are fortunate enough but a revolution which is coming whether we will it or not. We can affect its character; we cannot alter its inevitability"*

1963 - President Johnson played a critical role in the assassination of John F. Kennedy, working with the Mafia and CIA to have the rebellious Kennedy “taken out” in an Illuminati ritual sacrifice.

1968 ROBERT KENNEDY ASSASSINATED - Following dual victories in the California and South Dakota primary elections for the Democratic nomination for President of the United States, Senator Kennedy spoke to journalists and campaign workers at a live televised celebration from the stage of his headquarters at the Ambassador Hotel. Shortly after leaving the podium and exiting through a kitchen hallway, he was mortally wounded by multiple shots fired from a handgun.

1968, MARTIN LUTHER KING, JR. WAS ASSASSINATED - by a sniper's bullet while standing on the second-floor balcony of his room at the Lorraine Motel in Memphis, Tennessee. King, who was the nation's foremost civil rights leader, had returned to Memphis to lead a nonviolent march in support of the city's striking sanitation workers.

1971 – SOUTHERN POVERTY LAW CENTER (SPLC) – BAR attorneys in acts of high treason and lies the SPLC Intelligence Report, proclaiming to be the nation’s preeminent periodical monitoring the radical right in the United States, is fueling all government agencies and police departments into believing that anyone that uses specific words like militia, sovereign, oath keepers, constitution, patriots and even founding fathers, to name just a few, are armed, radicals and dangerous cop killers, whose names are put on the terrorist watch list. This agitation often causes police to over-react with excessive force and on a few occasions respond by SWAT when these words are used at traffic stops. Much of the over-reaction that fuels the police comes from that spews forth the lies of the Southern Poverty Law Center to unsuspecting law-enforcement agencies and departments. The SPLC is an arm of the BAR whose purpose is to excite violence by federal agents and police upon We the Sovereign People who are trying to make sense of our out of control federal judiciary and be free.

1975 - President Ford was one of the lucky presidents to survive an assassination due to misfiring. In fact, he survived two assassinations attempts in the same month.

1981 - Only 69 days after President Reagan took office for his first term, there was an attempted assassination by a gunman.

Out of 45 U.S. presidents, eight have been assassinated and four were attempted assassinations, for a total of twelve. Dr. Dave Janda claimed that President Trump has survived “close to a dozen” assassination attempts while in office.

1989 - President George Bush was a Globalist, member of the Bohemian Club, Skull and Bones, CFR, and the Trilateral Commission. He also served as the director of the CIA - an arm of the government heavily infiltrated by Masons - from 1976 to 1977.

1993 - President Clinton was a member of the Skull and Bones Society, Bilderberg Group, Trilateral Commission, and the Council on Foreign Relations.

2001 - President George W Bush played a key role in the September 11th false flag attack, the Patriot Act and war with Iraq. Bush was a member of the Skull and Bones Society, Bilderberg Group, Trilateral Commission, and the Council on Foreign Relations.

2009 - President Obama was hand-picked by the Illuminati to bring down the United States through socialism and staged conflicts. During his campaign, Obama selected the ubiquitous Zbigniew Brzezinski (CFR), promoter of the “regional” approach to world government, as one of his top foreign policy advisors. Obama called Brzezinski “one of our more outstanding thinkers” and “somebody he had learned an immense amount from.” Presumably Brzezinski’s teachings included the world government he advocates.

For decades, presidential candidates have been members of the Illuminati, making it virtually impossible for the country to elect a non-Illuminati leader. The Illuminati have influence not only in the politics of the United States, but in popular culture as well. CFR members control NBC, CBS, ABC, CNN, FOX, *The New York Times*, *The Washington Post*, and other important newspapers. *Time*, *Newsweek*, *Fortune* and *Business Weekly*

1993 – JAMES TRAFICANT'S BANKRUPTCY SPEECH - Speaker-Rep. James Traficant, Jr. (Ohio) addressing the House revealing the bankruptcy of the United States into the Congressional Record. All United States Offices, Officials, and Departments are now operating within a de facto status in name only under Emergency War Powers. With the Constitutional Republican form of Government now dissolved, the receivers of the Bankruptcy have adopted a new form of government for the United States. This new form of government is known as a Democracy, being an established Socialist/Communist order under a new governor for America.

2001 – HOMELAND SECURITY - Police state surveillance grid reached maturity

2013 – JOHN KERRY - Signed the United Nations Arms Treaty

2018 – NATIONS MUST GIVE UP THEIR SOVEREIGNTY - On 11/21/2018, German Chancellor Angela Merkel at an event by the Konrad Adenauer Foundation in Berlin stated that, “*sovereign nation states must not listen to the will of their citizens when it comes to questions of immigration, borders, or even sovereignty.*” And made it clear she is attempting to push the globalist agenda to its disturbing conclusion before 2021. Her words echo recent comments by the French President Emmanuel Macron who stated in a Remembrance Day speech that “*patriotism is the exact opposite of nationalism [because] nationalism is treason.*” Macron, told the German federal parliament that, “*France and Germany should be at the center of the emerging New World Order. The Franco-German couple [has]the obligation not to let the world slip into chaos and to guide it on the road to peace.
