

THE DECLARATION OF INDEPENDENCE

IN CONGRESS, JULY 4, 1776

The unanimous Declaration of the thirteen united States of America,

INTRODUCTION

When in the Course of human events, it becomes necessary for one people to dissolve the political bands which have connected them with another, and to assume among the powers of the earth, the separate and equal station to which the Laws of Nature and of Nature's God entitle them, a decent respect to the opinions of mankind requires that they should declare the causes which impel them to the separation.



COMMENTS:

The introduction to the Declaration of Independence declared the Peoples of the Thirteen American Colonies intent of three things:

- 1) Dissolving of their political bands with Britain for cause
- 2) Assume separate and equal stations with other nations
- 3) The People are entitled to live under the Laws of Nature and of Nature's God.

John Adams said: *“Our Constitution was made only for a moral and religious people. It is wholly inadequate to the government of any other.”* Thomas Jefferson said: *“The doctrines of Jesus are simple, and tend all to the happiness of man.”* And George Washington added: *“You do well to wish to learn our arts and ways of life, and above all, the religion of Jesus Christ. These will make you a greater and happier people than you are.”* And finally in James 1:25 God said: *“whoso looketh into the perfect law of liberty, and continueth therein, he being not a forgetful hearer, but a doer of the work, this man shall be blessed in his deed.”*

Many People do not understand that the Declaration of the thirteen United States of America is a Law document. It is the foundation of all American law, including equity. It is founded upon Natural Law a/k/a Common Law which is the only one true law, all other law, except equity under our Constitution, is derived from Babylon a/k/a Justinian law, roman law, municipality law, and law of the city and is written to control and enslave. Common Law traces its beginnings to 1400 BC when God gave His written Word to Israel. *“The advent of the written Word of God among the Anglo-Saxons in England brought a desire to read and then to write. Reading was necessary in order to discern the mind of God through His written Scriptures. God's Word encouraged writing that men may copy and translate the Scriptures; writing also enabled the production of the Lex Salica the earliest known record of Anglo-Saxon folk law issued on the European continent under King Clovis following his conversion to Christ in A.D. 496. The earliest written compilation of the Anglo-Saxon Volkriht (folk law) in England was issued by Ethelbert, the Christian king of Kent, about A.D. 865.”*¹ This was the beginning of Common Law in England and in 1215 the Magna Carter was the first known Common Law Document upon which the Declaration was written.

The Declaration of Independence is a short document written in plain language that needs little to no interpretation and is composed of eight (8) parts. (1) Introduction, (2) Preamble, (3) The right to alter government, (4) The right to abolish government, (5) List of abuses & usurpations (6) Repeated injuries for our Petitions of Redress, (7) Appeal to the Supreme Judge of the world and, (8) 56 witnesses. Like Noah and Moses We the People covenanted with God thereby acknowledging God as King who would rule through our courts and if obedient He would bless His People with Liberty, therefore no man can undo it.

PREAMBLE

We hold these truths to be self-evident, that all men are created equal, that they are endowed by their Creator with certain unalienable Rights, that among these are Life, Liberty and the pursuit of Happiness.--That to secure these rights, Governments are instituted among Men, deriving their just powers from the consent of the governed, --

COMMENTS:

The Preamble to the Declaration of Independence declares five truths under God's perfect law of liberty:

- 1) Truth is self-evident
- 2) All men are created equal
- 3) We are endowed by our Creator with unalienable Rights
- 4) Governments are instituted to secure these rights
- 5) Government derives their just powers from the consent of the governed

Jer 34:8 This is the word that came unto Jeremiah from the LORD, after that the king Zedekiah had made a covenant with all the people which were at Jerusalem, to proclaim liberty unto them;

The United States is a Republic and is to guarantee every state in this union to be a Republic.

Article V Section 4: *The United States shall guarantee to every state in this union a republican form of government, and shall protect each of them against invasion; and on application of the legislature, or of the executive (when the legislature cannot be convened) against domestic violence.*

Since the States lost their equal suffrage (equal vote) in the Senate via the 17th Amendment they are no longer sovereign because the Senate like the House of Representatives now performs the will of the special interest groups and not the State. Therefore States are no longer sovereign and therefore are no longer a republican form of government.

Article V: No state, without its consent, shall be deprived of its equal suffrage in the Senate.

A Republic is rule by law and not the whim of men. The law of a republic is a constitution written by either a small assembly of men that will eventually enslave its subjects, or written by Godly men under Gods Law which liberate His children. There were only three times in recorded history where a Nation was established under the Law of God. The first was the Nation of Israel (Exodus 4:22: "*Thus saith the LORD, Israel is my son, even my firstborn*") in about 1400 BC which self-destructed after 400 years when the people sought after a fleshly king. The second was in the middle of the first millennium in England which was destined to fail because like Israel men trusted their Liberty in a fleshly king and not God. The third was ordained by the children of the God in 1789 which was founded upon the 1776

covenant, whereas the Son said “*I will make a new covenant with the house of Israel ... I will put my laws into their mind, and write them in their hearts: and I will be to them a God, and they shall be to me a people*” (Hebrews 8:8-10). And it was in this fashion in 1789 that George Washington refused the crown with a bent knee to the Son and the United States became the city upon the hill reflecting the light of the gospel to a lost world (Mathew 5:13-16).

PRESERVATION OF THE RIGHT TO ALTER

That whenever any Form of Government becomes destructive of these ends, it is the Right of the People to alter or to abolish it, and to institute new Government, laying its foundation on such principles and organizing its powers in such form, as to them shall seem most likely to effect their Safety and Happiness. Prudence, indeed, will dictate that Governments long established should not be changed for light and transient causes; and accordingly all experience hath shewn, that mankind are more disposed to suffer, while evils are sufferable, than to right themselves by abolishing the forms to which they are accustomed. But when a long train of abuses and usurpations, pursuing invariably the same Object evinces a design to reduce them under absolute Despotism, it is their right, it is their duty, to throw off such Government, and to provide new Guards for their future security. --Such has been the patient sufferance of these Colonies; and such is now the necessity which constrains them to alter their former Systems of Government. The history of the present King of Great Britain is a history of repeated injuries and usurpations, all having in direct object the establishment of an absolute Tyranny over these States. To prove this, let Facts be submitted to a candid world.

COMMENTS:

The Preservation of the right to abolish or alter declares four rights when government becomes destructive:

- 1) Right to alter or to abolish government
- 2) Right to institute new Government
- 3) Under absolute Despotism it is the Peoples' right and duty to throw off such Government
- 4) Right to new Guards for future security

As it was in the last quarter of the eighteenth century that We the People via Committees of Safety, no different than the freemen via the Sureties of the Peace secured their Liberty in 1215AD [Magna Carta], dissolved the political bands with Britain and assumed among the powers of the earth, the separate and equal station to which the Laws of Nature and of Nature's God entitle us, thus establishing the United States of America one Nation under God with Liberty and Justice for all.

It is today in the first quarter of the twenty first century that We the People via the Sureties of the Peace² a/k/a Grand Jury by the mercy and grace of our Lord that we stand against the deep state to exercise our unalienable right to reinstate what has been removed and install new guard within our government that have become destructive to our government, via changing the guards through recall, indictments, and military tribunals.

² **SURETIES OF THE PEACE:** If anyone has been dispossessed without the legal judgment of his peers, from his lands, castles, franchises, or from his right, we will immediately restore them to him; and if a dispute arise over this, then let it be decided by the five and twenty jurors of whom mention is made below in the clause for securing the peace. Moreover, for all those possessions, from which anyone has, without the lawful judgment of his peers, been disseized or removed by our government, we will immediately grant full justice therein. Magna Carta Paragraph 52.

LONG TRAIN OF ABUSES & USURPATIONS

- *He has refused his Assent to Laws, the most wholesome and necessary for the public good.*
- *He has forbidden his Governors to pass Laws of immediate and pressing importance, unless suspended in their operation till his Assent should be obtained; and when so suspended, he has utterly neglected to attend to them.*
- *He has refused to pass other Laws for the accommodation of large districts of people, unless those people would relinquish the right of Representation in the Legislature, a right inestimable to them and formidable to tyrants only.*
- *He has called together legislative bodies at places unusual, uncomfortable, and distant from the depository of their public Records, for the sole purpose of fatiguing them into compliance with his measures.*
- *He has dissolved Representative Houses repeatedly, for opposing with manly firmness his invasions on the rights of the people.*
- *He has refused for a long time, after such dissolutions, to cause others to be elected; whereby the Legislative powers, incapable of Annihilation, have returned to the People at large for their exercise; the State remaining in the meantime exposed to all the dangers of invasion from without, and convulsions within.*
- *He has endeavored to prevent the population of these States; for that purpose obstructing the Laws for Naturalization of Foreigners; refusing to pass others to encourage their migrations hither, and raising the conditions of new Appropriations of Lands.*
- *He has obstructed the Administration of Justice, by refusing his Assent to Laws for establishing Judiciary powers.*
- *He has made Judges dependent on his Will alone, for the tenure of their offices, and the amount and payment of their salaries.*
- *He has erected a multitude of New Offices, and sent hither swarms of Officers to harass our people, and eat out their substance.*
- *He has kept among us, in times of peace, Standing Armies without the Consent of our legislatures.*
- *He has affected to render the Military independent of and superior to the Civil power.*
- *He has combined with others to subject us to a jurisdiction foreign to our constitution, and unacknowledged by our laws; giving his Assent to their Acts of pretended Legislation:*
- *For Quartering large bodies of armed troops among us:*
- *For protecting them, by a mock Trial, from punishment for any Murders which they should commit on the Inhabitants of these States:*
- *For cutting off our Trade with all parts of the world:*
- *For imposing Taxes on us without our Consent:*
- *For depriving us in many cases, of the benefits of Trial by Jury:*
- *For transporting us beyond Seas to be tried for pretended offences*
- *For abolishing the free System of English Laws in a neighboring Province, establishing therein an Arbitrary government, and enlarging its Boundaries so as to render it at once an example and fit instrument for introducing the same absolute rule into these Colonies:*
- *For taking away our Charters, abolishing our most valuable Laws, and altering fundamentally the Forms of our Governments:*
- *For suspending our own Legislatures and declaring themselves invested with power to legislate for us in all cases whatsoever.*
- *He has abdicated Government here, by declaring us out of his Protection and waging War against us.*

- *He has plundered our seas, ravaged our Coasts, burnt our towns, and destroyed the lives of our people.*
- *He is at this time transporting large Armies of foreign Mercenaries to complete the works of death, desolation and tyranny, already begun with circumstances of Cruelty & perfidy scarcely paralleled in the most barbarous ages, and totally unworthy the Head of a civilized nation.*
- *He has constrained our fellow Citizens taken Captive on the high Seas to bear Arms against their Country, to become the executioners of their friends and Brethren, or to fall themselves by their Hands.*
- *He has excited domestic insurrections amongst us, and has endeavored to bring on the inhabitants of our frontiers, the merciless Indian Savages, whose known rule of warfare, is an undistinguished destruction of all ages, sexes and conditions.*

COMMENTS:

Britain was once the guardian of the Natural Law but built into their system of government was a serious flaw namely a fleshly king that was to secure liberty for a free people. But instead, he ended up enslaving them. This was the very same thing that cursed the people of Israel as we read in God's Word:

1 Sam 8:6-22 But the thing displeased Samuel, when they said, Give us a king to judge us. And Samuel prayed unto the LORD. And the LORD said unto Samuel, Hearken unto the voice of the people in all that they say unto thee: for they have not rejected thee, but they have rejected me, that I should not reign over them. According to all the works which they have done since the day that I brought them up out of Egypt even unto this day, wherewith they have forsaken me, and served other gods, so do they also unto thee. Now therefore hearken unto their voice: howbeit yet protest solemnly unto them, and show them the manner of the king that shall reign over them. And Samuel told all the words of the LORD unto the people that asked of him a king. And he said, This will be the manner of the king that shall reign over you: He will take your sons, and appoint them for himself, for his chariots, and to be his horsemen; and some shall run before his chariots. And he will appoint him captains over thousands, and captains over fifties; and will set them to ear his ground, and to reap his harvest, and to make his instruments of war, and instruments of his chariots. And he will take your daughters to be confectionaries, and to be cooks, and to be bakers. And he will take your fields, and your vineyards, and your oliveyards, even the best of them, and give them to his servants. And he will take the tenth of your seed, and of your vineyards, and give to his officers, and to his servants. And he will take your menservants, and your maidservants, and your goodliest young men, and your asses, and put them to his work. He will take the tenth of your sheep: and ye shall be his servants. And ye shall cry out in that day because of your king which ye shall have chosen you: and the LORD will not hear you in that day. Nevertheless the people refused to obey the voice of Samuel; and they said, Nay; but we will have a king over us; That we also may be like all the nations; and that our king may judge us, and go out before us, and fight our battles. And Samuel heard all the words of the people, and he rehearsed them in the ears of the LORD. And the LORD said to Samuel, Hearken unto their voice, and make them a king. And Samuel said unto the men of Israel, Go ye every man unto his city.

By God's mercy George Washington refused the crown and thereby we became a nation of Natural Law where God would rule as judge through our courts. Thereby, legislative and administrative undertakings will be as "just" as our courts. But as long as We the People allow these judges, that have unlawfully seized control of our courts, to deny us access and continue in their denial of God's rule we

will continue under their tyranny. We the People need to come to the knowledge of truth and trust that God will honor his promises and only then will we become a “Just Nation” again.

Today we have come full circle and we too have a “Long Train of Abuses” that our servant government has usurped. The following is the short list of violations by our servant government today:

- They have refused obedience to the Constitution
- They have abrogated the states sovereignty via the 17th Amendment
- They have abrogated the Peoples sovereignty via the 16th Amendment
- They have replaced our unalienable rights gifted by our Creator with privileges via the 14th Amendment, a direct assault upon the Peoples covenant with God, by repugnantly claiming the free and independent People are now subject to the laws of the United States and the States, when in fact the United States and the States are subject to the People.
- They have created debtors prisons controlled by foreign bankers for their unlawful tax schemes.
- They have abrogated natural law courts.
- They have reinstated Roman law a/k/a Babylonian law under the name “civil law, via rule 2.
- They have abrogated the Peoples’ right of representation via lobbying.
- They have surrendered control of our currency to foreign bankers
- They have turned over our federal courts to foreign bankers under the pretense of a fictional Article I court
- They have turned our currency to debt thereby destroying our economy
- They have exposed us to dangers of invasion via unprotected borders and exhausting our militia in foreign wars
- They have seized control of counting our votes and do so in secrete
- They have permitted voting by illegal aliens
- They have turned over control of our courts and the writing of our laws to a foreign entity via the ABA
- They have made Judges dependent upon status quo rulings
- They have erected a multitude of new offices, and sent hither swarms of officers to harass the people, and eat out their substance
- They have empowered the deep state to keep us in perpetual wars
- They have concealed and seized control of the Peoples’ right of government by consent
- They have combined with others to subject us to a jurisdiction foreign to our constitution
- They have given assent to acts of pretended legislation
- They assault innocent People with trumped-up charges and swat teams
- They impose taxes on us without our consent
- They have deprive us in many cases of the benefits of trial by Jury
- They transport us to jurisdictions unknown to be tried for pretended offences
- They subject People to federal laws without authority claiming absolute rule over these States
- They have abrogated our Common Law a/k/a Natural Law
- They have fundamentally altered the forms of our governments
- They have declared themselves invested with power to legislate for us in all cases whatsoever
- They have relinquished State Government powers while waging war against patriotic People

REPEATED INJURY FOR OUR PETITIONS OF REDRESS

In every stage of these Oppressions We have Petitioned for Redress in the most humble terms: Our repeated Petitions have been answered only by repeated injury. A Prince whose character is thus marked by every act which may define a Tyrant, is unfit to be the ruler of a free people.

Nor have we been wanting in attentions to our British brethren. We have warned them from time to time of attempts by their legislature to extend an unwarrantable jurisdiction over us. We have reminded them of the circumstances of our emigration and settlement here. We have appealed to their native justice and magnanimity, and we have conjured them by the ties of our common kindred to disavow these usurpations, which would inevitably interrupt our connections and correspondence. They too have been deaf to the voice of justice and of consanguinity. We must, therefore, acquiesce in the necessity, which denounces our Separation, and hold them, as we hold the rest of mankind, Enemies in War, in Peace Friends.

COMMENTS:

To prevent future injury as our founding fathers so suffered before us We the People wrote:

Amendment I “Congress shall make no law abridging the freedom of the right of the people peaceably to assemble, and to petition the Government for a redress of grievances.”

But we forgot and our servants took advantage of our ignorance and so we find ourselves here once again! We too have petitioned for redress in the most humble terms: We have invited them to forums to discuss the issues and they declined. We have called forth the Third Continental Congress and delivered upon them our demands as a free People and they have ignored us. We have summonsed the Sureties of Peace and delivered upon them Quo Warranto and numerous Writs of Mandamuses. And our repeated petitions also have been answered only by repeated injury. We were met with accusations of being terrorists and “sovereign citizens” which is code for cop killers thereby placing our lives in jeopardy and they have sent out upon us swarms of agents from the Treasury Department, FBI and they have weaponized the IRS upon us and our families.

APPEAL TO THE SUPREME JUDGE OF THE WORLD

We, therefore, the Representatives of the united States of America, in General Congress, Assembled, appealing to the Supreme Judge of the world for the rectitude of our intentions, do, in the Name, and by Authority of the good People of these Colonies, solemnly publish and declare, That these United Colonies are, and of Right ought to be Free and Independent States; that they are Absolved from all Allegiance to the British Crown, and that all political connection between them and the State of Great Britain, is and ought to be totally dissolved; and that as Free and Independent States, they have full Power to levy War, conclude Peace, contract Alliances, establish Commerce, and to do all other Acts and Things which Independent States may of right do. And for the support of this Declaration, with a firm reliance on the protection of divine Providence, we mutually pledge to each other our Lives, our Fortunes and our sacred Honor.

COMMENTS:

Appeal to the Supreme Judge Ultimately this is Gods battle, it is His court that they robbed, it is His People they have abused we need only come to the knowledge of truth, take a stand and wait on Him to lead us in judgment and in righteousness. He shall set the stage as he promised³.

- 1) We the People Assembled, appeal to the Supreme Judge of the world
- 2) We have a Right to be Free and Independent States

³ Isa 14:1-7 For the LORD will have mercy on Jacob, and will yet choose Israel, and set them in their own land: and the strangers shall be joined with them, and they shall cleave to the house of Jacob. And the people shall take them, and bring them to their place: and the house of Israel shall possess them in the land of the LORD for servants and handmaids: and they shall take them captives, whose captives they were; and they shall rule over their oppressors. And it shall come to pass in the day that the LORD shall give thee rest from thy sorrow, and from thy fear, and from the hard bondage herein thou wast made to serve. That thou shalt take up this proverb against the king of Babylon, and say, How hath the oppressor ceased! the golden city ceased! The LORD hath broken the staff of the wicked, and the sceptre of the rulers. He who smote the people in wrath with a continual stroke, he that ruled the nations in anger, is persecuted, and none hindereth. The whole earth is at rest, and is quiet: they break forth into singing.

To solve these problems seem overwhelming, and it is! But God has sent us a type of Cyrus in President Donald Trump, [see the book of Ezra], to dismantle the deep state and bring the NWO under judgment, see Isaiah chapter 14. This will provide an opportunity for We the People to reclaim our government and bind them down with the chains of the Constitution. And this starts with an education of our heritage and an acknowledgement of our creator and his laws. And then and only then will we be answered. Like our founding fathers we too can be empowered through the knowledge and the exercising of our God given Liberties within His will.
