## FORM A GRAND JURY - HOW TO GET STARTED!

(YOU CAN HAVE AN ACTIVE GRAND JURY WITHIN TWO WEEKS AFTER REGISTERING AS ORGANIZER, DO IT!)

## **REGISTER AS AN ORGANIZER**

**Step 1** Go to <u>http://nationallibertyalliance.org/pages/private.html</u> and take the 3½ hour orientation workshop. When done at the bottom of the page click on "**FOR DETAILS TO START A GRAND JURY CLICK HERE**" watch the video and download the documents (zip-file)

**<u>Step 2</u>** Immediately find at least two people (family, friends, neighbors) who will come to the election vote and sign as witness weather they choose to participate or not.

**Step 3** Call the Library in your county seat and book the conference room tell them it is for a public service, "<u>an introduction to the Grand Jury process and election</u>". The Library is a public building it is free to anyone who is promoting a public service. If you cannot book the conference room within a week or two go to another town close by, if worse comes worse book the back room at Denny's or some other place, do not use a political party hall, we are not about politics we are about honor and justice.

**Step 4** As soon as you confirm a venue call the newspapers in your county ask to speak to whoever handles the press releases they will usually give you a fax or an email to send the "press release" use the press release from the zip-file in step #1, print out a fax or email receipt (proof) for your declaration explained in step #1, if the news fails to post don't concern yourself, you are in honor they are in dishonor.

<u>Step 5</u> Call everyone you know and invite them to the election and ask them to do the same you can also invite people from the following venues. [if only three people show up you have done your best, move on]

**<u>#1 Go to</u>** http://www.meetup.com/ and search for liberty groups like "912", "we surround them", tea party, Ron Paul, and other groups. Visit the groups and click on the names of the organizers to send them a message. Briefly tell them about our Grand Jury project and give them your number and ask them to call you.

**#2** Go to http://www.teaparty911.com/info/locations/alabama.htm and click on your state on the left side and you will find numerous contacts many with phone numbers, call them and explain how powerful our program is and ask them to view our power point/video at http://nationallibertyalliance.org on the Power of the Grand Jury and after to call you back. **#3** Go to http://connect.freedomworks.org/ (Freedom Connector) sign up and create a profile. (this is a great tool to connect to people). Then create a group called "[Your state] Liberty Alliance". (If someone else has already created this group, introduce yourself to the founder and let them know that you are posted as a organizer on NY Committeemen and they will make you an admin in the group)

**Step 6** You only need 4 active people willing to learn and serve full time handling the daily administrations, investigations, and will rotate being the foreman when a Grand Jury is called. Once we are established and recognized as the Grand Jury we will submit our budget to the state and these four people will be paid a salary. When a jury grand or trial is called we will draw jurist from our registry and the voters registration list and we will create a video and literature for orientation, and all who serve will take an oath. Once the County Grand Jury is constituted see the document "<u>HOW TO HANDLE THE PRESS</u>"!
