

# What We Know About the Coronavirus

- 1) “This is clearly an offensive biological warfare agent and it has no legitimate medical or other [use].”
- 2) “I think I have the definitive evidence where this came from and it came from the BSL-3 biowarfare lab at the University of North Carolina.”
- 3) “... these best scientists at the University of North Carolina took dirty money from China to allow that one of their top biowarfare experts from this Wuhan Institute of Virology and Wuhan, which has the BSL-4 facility, they knew exactly what they were doing, and they permitted this Chinese scientist to work with them to give gain of function [super-weaponize] biowarfare DNA genetic capability to SARS.”

- 7) “Let me also say we can’t trust the FBI to do the right thing here. They lied about, they covered up and they sabotaged the Amerithrax coming out of Fort Detrick. We are going to have to get some other federal law investigative agencies in here to deal with that North Carolina.”
- 8) [It is a chimera, a splicing of several viruses, with] “gain of function to coronavirus for efficient spreading in the human population”.
