Dear Attorney General Sessions,

It has been thirty days since notifying you of ~~We~~ the ~~Peoples~~' extraordinary proceeding filed under case NO. 1:16-CV-1490 in the Northern District of New York concerning subversion by enemies both foreign and domestic, murder, torture, RICO, concealment, conspiracy to supplant the Law of the Land, denial of due process, non-judicial foreclosures, kidnaping, etc.

On February 9, 2017, President Trump announced, "*with great pride, very great pride*" your appointment in that you have "*devoted your life to JUSTICE and believes deeply that all people are equal in the eyes of the Law and the eyes of God [which includes judges], a man of Integrity, a man of Principle and total Utter Resolve*". President Trump went on to say, and ~~We~~ the ~~People~~ agree that, "*that resolve is what America needs right now! ... The job of the Attorney General is to serve and protect the ~~People~~ of the United States and that is exactly what he will do ... a great protector of the People*". You then placed your left hand on the Bible, raised your right hand and said"

*"I Jeff Sessions do solemnly swear that I will support and defend the Constitution of the United States against all enemies Foreign and Domestic that I will bear true faith and allegiance to the same that I take this obligation freely without any MENTAL RESERVATIONS OR PURPOSE OF EVASION and that I will well and faithfully discharge the duties of the office in which I am about to enter, so help me God!"*

Therefore, we anticipated a swift written honorable response from our first letter to you concerning your constitutional duties that you took the aforesaid oath to support and defend. The silence emanating from your office concerning our communique` is deafening and we would like to remind you that you are the "*guardian of the public interest*", and that:


<sup>1</sup> **The UUSCLGJ** is comprised of fifty Grand Jurys each unified amongst the counties within their respective States. All fifty States have unified nationally as an assembly of Thousands of People in the name of We the People to suppress, through our Courts of Justice, subverts both foreign and domestic acting under color of law within our governments. States were unified by re-constituting all 3,133 United States counties.

*“Silence can only be equated with fraud where there is a legal or moral duty to speak, or where an inquiry left unanswered would be intentionally misleading...” U.S. v. Tweel, 550 F.2d 297, 299. See also U.S. v. Prudden, 424 F.2d 1021, 1032; Carmine v. Bowen, 64 A. 932*

Therefore, ~~We~~ the ~~People~~ reiterate: *“If you are unable to find and supply us with such prosecutors we know of at least one qualified common lawyer who was once a prosecutor and still practice’s law that we can call upon who is able to prosecute and brief other prosecutors in the practice of common law.”* We await your immediate written honorable response.
