TO THE TUESDAY 19 MARCH TERM OF TH McMINN COUNTY TENNESSEE GRAND JURY

PREAMBLE

Grand Juries are the most powerful law enforcement agencies known in human history.

This Grand Jury, all Grand Juries are empowered to initiate and conduct their own independent and autonomous investigations, independently and free from interference from attorneys or judges.

A formal criminal complaint formed and advanced by a Grand Jury is defined and described as a **PRESENTMENT!**

In the exercise of its **POWER OF PRESENTMENT**, this Grand Jury, all Grand Juries are first and foremost empowered to stand against and wipe out corruption in government.

Grand Juries are empowered to initiate and conduct their own independent and autonomous investigations, independently and free from interference from attorneys or judges precisely because an attorney or judge is in fact the object of the Grand Jury's scrutiny.

Individuals who are otherwise recognized as a JUROR is accused of a criminal activity, that JUROR looses their standing as JUROR to hear the case wherein their name appears.

MY CRIMINAL COMPLAINT – WRITTEN EXECUTIVE BRIEF

I live in Athens, Tennessee.

During that year I've been reporting on massive government corruption.

I remain under constant threat of death, in Athens, Tennessee, because of what I've discovered, because of what more I may discover taken together with my willingness and ability to publically report the corruption.

My life is at risk coming hear today.

In the exercise of a criminal act, federal and state law enforcement officials identify me as a domestic terrorist, a sovereign citizen, and a vigilante. I am described as a man just like Timothy McVeigh (the Oklahoma bomber), James W. von Brunn (the 2010 Holocaust Museum shooter/killer), and James Cummings (a Nazi sympathizer from Maine). I am routinely targeted as an armed white supremacist, the object of contempt unworthy and unsuited to continue on in life. I am described with others as a member of an "Axis of anti-Americanism."

I am quite certain my name appears on state and federal terrorist watch lists.

I am being cyber-stalked.

Engaged, encouraging and nurturing this criminal activity, working from their Athens, Tennessee office located at 130 E. Washington Avenue, Suite 3, are Carroll Lee Ross and his personal assistant Denise Barnes.

Others accused in this complaint who also work in Athens, Tennessee include Robert Steven Bebb, Paul D. Rush, and James H. Stutts.

Other Tennesseans naming me as a "gun-totin' domestic terrorist" include Martha M. Marty Cook, Bruce Arp, Rene Ezell, Allan Watson, Gregg Breeden, Bill Bivens, Mike Morgan, Donald Paul Harris, Dwayne Collins, Dan Gilley, Donald Paul Harris, Walter C. Kurtz and Jon Kerry Blackwood, Mark A. van Balen, Scott Johnson, Mike "Too Tall" Hall, and Don Williams. This list is not exhaustive.

One week ago, on the morning of Monday, 11 March 2013 I discovered that an OBAMA White House attorney is participating with and behind the campaign that targets me as a sovereign citizen and domestic terrorist.

Many more who live outside of Tennessee State are part of the campaign to destroy me.

What have I done to draw down this vicious retaliation? Well, I'm very good in the use of a whistle!

I'm prepared to more fully report to this Grand Jury what I've been blowing a whistle about.

Part of my narrative includes exposition of a corrupt and corrupted Grand Jury scheme. Tennessee judges refuse to obey state statutes set down regarding the scope and operation of Tennessee Grand Juries. Using the example of Mr. Jeff Cunningham I'm prepared to explain more completely. Mr. Cunningham is right now in violation of state and federal law should he be standing in this room as you review my sworn affidavit.

Beyond the discovery of the White House attorney's criminal political activism in the sovereign citizen campaign, Jeff Cunningham inspires my return to the March 2013 Term of the McMinn County Grand Jury.

I told Jeff Cunningham last month, attempting to speak to the February 2013 Term of this Grand Jury I was a declared sovereign citizen and domestic terrorist. Cunningham didn't believe and tossed out my 35-page report with the days coffee grounds. So I'm back this month with more.

What can you do as a Grand Jury? You can do what the Framers of the Constitution empowered you to do. You can exercise your power of PRESENTMENT. Begin an autonomous and independent Grand Jury investigation today, follow where it leads, then hand down PRESENTMENTS as investigative your work product dictates. You can do this on your own authority. No one needs give you permission.

Your inspection into these matters starts by calling me in today. Capture a sense of what I'm able to report to the full Grand Jury, and then recommend that I appear.

Then with your Grand Jury colleagues, schedule me back for as many appearances as you deem necessary. Conduct the rest of your investigation as you desire. One goal is to put an end to the tyrannical "sovereign citizen" campaign!

Beyond myself you'll come to learn many others live under death threats and more, again, because they're trying to report what they know regarding government corruption.

Your work will spawn the necessary involvement of other Grand Juries and countless law enforcement agencies across the country. I can all begin today by calling me in to give you the verbal executive brief and give you a sense regarding the enormity of these situations.
