Committeemen monitor elected individuals to insure they don’t overstep their authority


Committeemen solve problems with bureaucrats reported by people from their election district.

Committeemen can enforce the Republic Review where the states come together to remove unconstitutional legislation

Committeemen can force legislation for term limits.



The Resolve of the COS is to promote an educated citizenry which is required in order to have “Government by Consent,” thereby ending government encroachment upon our Liberties. The common goal of each COS is to teach the People what they have forgotten! This requires an understanding of how a “Natural Law Republic” was established by the providence of nature’s God and how it works. Every members of the COS must be active and properly educated. As Jefferson said, “If a People expect to be Ignorant and free they expect what never was and never will be.” Eternal vigilance is required in order to secure Liberty.

There are no problems that a COS cannot solve. And there are many initiatives that your COS must advance within their respective counties. Such as bringing a proper education back into our schools, prevent agenda 21, monitor fair elections, remove tyrants and criminals from office, end political factions, enforce the Law of the Land, etc. But after forming your COS General Committee the first order of business is to form and initiate the following “sub-committees” in order to gain power and take back our unalienable right of “Government by Consent” and once this is accomplished we will be empowered to bind down our government servants with the chains of the Constitution. The COS, in general, is responsible for addressing problems and all sub-committees are to report their findings to the COS General Committee members for discuss and consider the sub-committees proposed solutions. SUB – COMMITTEE



COMMITTEE OF CORRESPONDENCE

This committee is responsible for addressing unconstitutional government activity and correspond with other County Committees of Correspondence in order to share solutions and work on common problems that affect other counties within their state or across our Nation. You can go to our [“National Issues Tab,”](#) under [“Start a Committee of Safety Tab”](#) and read about proposed national issues that we need to address. NLA’s Committee of Correspondence will meet once a month to discuss the issues and brainstorm other issues that we will post on said national issue page. The strategy is to for CCOS to discuss the issues and then bring the issues back to their General Committees for action, by contacting our Congressional Representatives to demand that they solve the issues as we addressed them. If our representatives do not respond positively let them know if they are going to continue to disobey us we will recall them or not support their candidacy if the election is close. If enough CCOS force their obedience we will succeed. This is why it is important to initiate CCOS in our neighboring counties to form CCOS and work together on national and state issues. The chairman of the Political Committee is responsible for contacting our representatives on these issues and the General Committee will act in one accord to remove these unfaithful servants if necessary. SUB – COMMITTEE

EDUCATION COMMITTEE



This committee is responsible for visiting schools within their county, elementary to college and require that civics, constitutional studies, real American history, and court access is taught. And that anything being taught in these schools that are destructive to our Natural Law Republic must cease immediately. Remember all schools receive federal funding and they are required to teach civics or lose their funding. Also this is why your educational committee should be busy in their communities campaigning for an education of the People and encourage their participation. These people should go to the school board with your committee to force compliance. Next monthly meeting NLA will teach how to require obedience from school and town boards and if they refuse how they can be held accountable and be removed from office within 10 days.



SUB – COMMITTEE

POLITICAL COMMITTEE



This committee is responsible for receiving, contacting, and communicating with individuals interested in filling political positions and reporting back to the full committee those candidates that are worthy of our support. Whereas, the entire COS will act as the “True non-statutory Committeeman” to get these candidates onto the ballot by walking designating petitions, [for more details on this process go download to handbooks and download the “COS Committeeman Handbook.”](#) A Natural Law Republic, such as the “United States” cannot survive the continuance of political parties that are “private associations” initiated by BAR Attorneys and designed to be controlled by “party bosses.” As President George Washington in his farewell address put it:

“Parties lead to despotism, serve to organize division, ruin public liberty, kindle animosity of one part against another, put in the place of the delegated will of the nation, the will of the party elite, undermine the Constitution which could not be directly overthrown, distract the public councils and enfeeble the public administration, drive the spirit of revenge, and opens the door to foreign influence and corruption, thus the policy and the will of one country will be subjected to the policy and will of another, Washington concluded, “parties are truly your worst enemy.”

Committees of Safety can overtake and replace the statutory-committeeman and end the private party associations that have been destroying our Republic since its inception; by just exercising their “Natural Law Right” of “Government by Consent.”



SUB – COMMITTEE

JUDICIAL COMMITTEE



JUDICIAL COMMITTEE: This committee is responsible for filling Jury Administrative positions whenever there is a vacancy. Each county needs four Jury Administrators and one paralegal secretary. These are paid positions and require special training. NLA provides that training and certification. These administrators will work together in every county to restore the Law of the Land by resurrecting common law and common law rules in our courts. This committee will assist people with bureaucratic problems and if unable to solve the problem they will notify the Jury Administrators who are trained to solve the problem.



SUB – COMMITTEES

MILITIA COMMITTEE



This committee is responsible for restoring the organized and unorganized militia within their respective counties, it is the duty of every COS member to participate. We should look for an existing militia within your county to invite them to join and help the COS in this endeavor. We should look to ex-military and the Sheriff for assistance in organizing and training. Plan and have your monthly meeting [*keep the 1st Monday of the month open for National Meeting*]. At the first meeting Adopt your [Charter and Resolutions](#); Find both documents at [“Handbooks, Videos and Tools Tab”](#) under [“Start a COS Tab”](#) It is important to maintain the forms structure and add to it as necessary. You can change or add to your Charter and Resolutions at future meetings.

Go to Staples or Office Max to get a [“Seal”](#) find example on page 18 of the Handbook. Have them print out your Charter and Resolutions and bind them. Use your [“Seal”](#) to seal them. Purchase the Book “Government by Consent” found under [“Books by John Darash Tab”](#) found under the [“Welcome Tab.”](#) Then Contact your Sheriff for a short meeting no more than 5 to 10 min. Introduce your COS and give him a copy of your “Charter, Resolutions, and the Book Government by Consent. Then invite him to your next months COS Meeting. Find more details in Handbook page 18.
