

## TREASON BY ENEMIES DOMESTIC

*“No man can renounce the country in which he was born, nor abjure the obligation of his allegiance.” – Maxim of Law from Bouvier’s*

**NATURAL ALLEGIANCE** – *“In American law, the allegiance due from citizens of the United States to their native country, and also from naturalized citizens, and which cannot be renounced without the permission of government, to be declared by law.” Black’s Law; 2 Kent, Comm. 43-49.*

**CITIZEN** – *“In American Law one who, under the constitution and laws of the United States, or of a particular state, is a member of the political community, owing allegiance and being entitled to the enjoyment of full civil rights.” Black’s Law; Amy v. Smith, 1 Litt. (Ky.) 331; Minor v. Happersett, 21 Wall. 162, 22 L.Ed. 627.*

**14<sup>TH</sup> AMENDMENT** – *“All persons born or naturalized in the United States, and subject to the jurisdiction thereof, are citizens of the United States and of the state wherein they reside.”*

**US SUPREME COURT** – *“The citizen or subject owes an absolute and permanent allegiance to his government or sovereign until he becomes a citizen or subject of another government or another sovereign.” U.S. v. Wong Kim, Ark., 169 U.S. 649, 18 Sup.Ct. 456, 42 L.Ed. 890.*

**4 USC §4** – *“I pledge allegiance to the Flag of the United States of America, and to the Republic for which it stands, one Nation under God, indivisible, with liberty and justice for all.”*

Every school age child pledges their allegiance to the Republic every day throughout their education. All local government meetings level and sporting events start with the Pledge of Allegiance being recited, and Congressional sessions are also opened with the Pledge. It is a daily reminder of an oath that every American is reminded of. The pledge of allegiance is not pledging a loyalty to a government, ideology, an individual, or a man derived republic. It’s a pledge to a Natural Law Republic derived from nature’s God! Anyone betraying that allegiance denies liberty and justice for all Americans, they are a traitor, and worse rebellion against God.

## ELECTED AND APPOINTED REPRESENTATIVES

**5 USC §3331 OATH OF OFFICE**: Every elected or appointed bureaucrat takes the following Oath:

*“I, \_\_\_\_\_, do solemnly swear (or affirm) that I will **support and defend the Constitution** of the United States **against all enemies**, foreign and domestic; that I will bear **true faith and allegiance** to the same; that I take this obligation freely, without any mental reservation or purpose of evasion; and that **I will well and faithfully discharge the duties of the office** on which I am about to enter. So help me God.”*

Jefferson said: *“The Republican is the only form of government which is not eternally at open or secret war with the rights of mankind.”* Therefore, if an individual holding an “office of trust” after taking an oath uses their office to levy war against our “Natural Law Constitutional Republic” is “eternally at war with the rights of mankind,” and is guilty of treason by virtue of subversive behavior for the purpose of overthrowing or destroying a “Lawfully Constituted Government”. Such person is in bad-behavior, should be removed from office, and indicted for treason.

All People born, or naturalized a citizen of the United States owes an allegiance to our “Natural Law Republic” and are free to think, believe and discuss marxism, communism, socialism, and any other ism they please as long as they do not:

- 1) Advocate, abet, advise, or teaches the duty, necessity, desirability, or propriety of overthrowing or destroying the government of the United States, or
- 2) Organize or helps or attempts to organize any society, group, or assembly of persons who teach, advocate, or encourage the overthrow our Republic, or
- 3) Become a member of, or affiliates with, any such society, group, or assembly of persons, knowing the purposes thereof, being the destruction of our Republic, or
- 4) Incites, sets on foot, assists, or engages in any rebellion or insurrection against the authority of the United States or the laws thereof, or
- 5) Levies war against the United States, adheres to the enemy, gives aid and comfort within the United States or elsewhere.

The American Bar Association advocates, abets, advises, and teaches subversion of our Republic, teaching all ABA taught attorneys that \ Natural Law has been abrogated via federal rule 2 that they authored.

The Federal Judiciary gives aid and comfort to the enemy of our Republic by ignoring their oath to the Constitution in order to protect the Deep State and their corporations. Most federal judges are ABA taught and uphold rule 2 above the Law of the Land.

Congress gives aid and comfort to the enemy of our Republic by passing unconstitutional codes and statutes written by ABA attorneys.

Pre Trump Presidents gave aid and comfort to the enemy of our Republic adhering to an Oligarchy contrary to the will of the People.

**18 USC §2381** - Treason Whoever, owing allegiance to the United States, levies war against them or adheres to their enemies, giving them aid and comfort within the United States or elsewhere, is guilty of treason and shall suffer death, or shall be imprisoned not less than five years and fined under this title but not less than \$10,000; and shall be incapable of holding any office under the United States.

**18 USC §2382** - Misprision of treason: Whoever, owing allegiance to the United States and having knowledge of the commission of any treason against them, conceals and does not, as soon as may be, disclose and make known the same to the President or to some judge of the United States, or to the governor or to some judge or justice of a particular State, is guilty of misprision of treason and shall be fined under this title or imprisoned not more than seven years, or both.

**18 USC §2383** - Rebellion or insurrection - Whoever incites, sets on foot, assists, or engages in any rebellion or insurrection against the authority of the United States or the laws thereof, or gives aid or comfort thereto, shall be fined under this title or imprisoned not more than ten years, or both; and shall be incapable of holding any office under the United States.

**18 USC §2384** - Seditious conspiracy - If two or more persons in any State or Territory, or in any place subject to the jurisdiction of the United States, conspire to overthrow, put down, or to destroy by force the Government of the United States, or to levy war against them, or to oppose by force the authority thereof, or by force to prevent, hinder, or delay the execution of any law of the United States, or by force to seize, take, or possess any property of the United States contrary to the authority thereof, they shall each be fined under this title or imprisoned not more than twenty years, or both.

**18 USC §2385** - Advocating overthrow of Government - Whoever knowingly or willfully advocates, abets, advises, or teaches the duty, necessity, desirability, or propriety of overthrowing or destroying the government of the United States or the government of any State, Territory, District or Possession thereof, or the government of any political subdivision therein, by force or violence, or by the assassination of any officer of any such government; or Whoever, with intent to cause the overthrow or destruction of any such government, prints, publishes, edits, issues, circulates, sells, distributes, or publicly displays any written or printed matter advocating, advising, or teaching the duty, necessity, desirability, or propriety of overthrowing or destroying any government in the United States by force or violence, or attempts to do so; or Whoever organizes or helps or attempts to organize any society, group, or assembly of persons who teach, advocate, or encourage the overthrow or destruction of any such government by force or violence; or becomes or is a member of, or affiliates with, any such society, group, or assembly of persons, knowing the purposes thereof Shall be fined under this title or imprisoned not more than twenty years, or both, and shall be ineligible for employment by the United States or any department or agency thereof, for the five years next following his conviction. If two or more persons conspire to commit any offense named in this section, each shall be fined under this title or imprisoned not more than twenty years, or both, and shall be ineligible for employment by the United States or any department or agency thereof, for the five years next following his conviction. As used in this section, the terms “organizes” and “organize”, with respect to any society, group, or assembly of persons, include the recruiting of new members, the forming of new units, and the regrouping or expansion of existing clubs, classes, and other units of such society, group, or assembly of persons.
