Let us begin with the law of the Land, i.e. the **Constitution** and its capstone, **Bill of Rights**. Most people are surprised to learn that they have no Constitutional rights and in realizing such, their path to knowledge begins. We have unalienable rights. We the People and our children must become educated in American History; not so much the battle dates and wars, but the documents that are the cornerstone of this Republic and the chronology of events, that came to pass before during and after the birth of this nation. It was not constructed overnight. It took years of trial and error, and the trials and trepidations of great minds to arrive at their conclusions of law, so as to protect themselves, their posterity and the posterity of generations to come.

We need to read, study and UNDERSTAND the **Declaration of Independence** and its history, and the **Constitution** and its **Bill of Rights**, **Civics** and **government**. Three of these will take several hours to read and then as long as you wish to understand them to the point of defending yourself in a court of Record.

We will provide that education for you here at NLA. Most of us come to NLA dumb as a box of rocks when it comes to the Constitution; the law of the Land. I address myself first to that condition.
