Dear Mr. Sutton;

The purpose of this communiqué is to first address your concerns as to whether the Unified United States Common Law Grand Jury (UUSCLGJ) is in dishonor by collecting money to file Habeas Corpuses and not filing them or any other papers in the court, and second address your claims that you are an NLA leader and were privy to some damming inside information.

The UUSCLGJ is not an entity that receives or solicits monies for any purpose; and, certainly does not and cannot charge fees for any papers that they serve. Whereas the UUSCLGJ acts upon "any" prima facia petition from any person for a writ of habeas corpus and serves other papers on behalf of "We the People" in an endeavor to encourage and sometimes demand that our public servants obey the "Law of the Land" Article VI clause 2. Although we serve on the courts with a cover letter "File on Demand", most courts violate 18USC §1001;

*"(a) Except as otherwise provided in this section, whoever, "knowingly and willfully (1) conceals, or covers up by trick, scheme, or device a material fact; ..."*

The necessary funding to pay the cost for such petitions should be paid by the courts, but they refuse to acknowledge or fund the costs for the Peoples unalienable right of due process through habeas corpus. Therefore, NLA donates paper, toner, envelopes and postage in order to send out habeas corpuses, informations and other court filings and services.

Mr. Sutton, your claims that you are an NLA leader and that you and others have claim that papers are "not" being filed is untrue, and therefore puts you in dishonor. The first habeas corpus filed by the UUSCLGJ was on May 5, 2015. To date the status of Writs of Habeas Corpus is as follows:

- Twenty-five (25) Writs of Habeas Corpus have been served
- Nineteen (19) petitioners who have submitted notarized Affidavits
- Twenty-nine (29) petitioners have partial submissions
- Ninety (90) other people have inquired of us how to Petition

Presently we are not taking any more requests for Petition for Writ of Habeas Corpus, until further notice.

Mr. Sutton, making accusations of fraud against jurists and attempted intimidation by threatening the seizure of a jurist's home or assets in order to influence some outcome places you subject to Obstruction of justice:

18 USC §1503 – “Influencing or injuring officer or juror generally (a) Whoever corruptly, or by threats or force, or by any threatening letter or communication, endeavors to influence, intimidate, or impede any grand or petit juror ... on account of the performance of his official duties, or corruptly or by threats or force, or by any threatening letter or communication, influences, obstructs, or impedes, or endeavors to influence, obstruct, or impede, the due administration of justice, shall be punished as provided in subsection (b).”

Additionally, Mr. Sutton your admission of “having audio” might prove you in violation of 18 USC §1508:

“Recording, listening to, or observing proceedings of grand or petit juries while deliberating or voting.”

The UUSCLGJ are investigating and reporting subversion against the United States of America by enemies foreign and domestic within our governments. Therefore, if you and/or others are government agent provocateurs, directly or by contract, acting under the color of law, might show cause for indictments for conspiracy, subversion, spying on the Grand Jury, treason and warring against the Constitution.

You are hereby ordered to cease and desist all unlawful activities immediately.
