Dear President Trump, et al,¹

My name is John Darash, co-founder of member supported National Liberty Alliance which is the sponsor for the Unified United States Common Law Grand Jury, (UUSCLGJ). We owe no allegiance but to God alone. The mission and purpose of National Liberty Alliance is to provide an online National Venue where the People can organize, communicate, and learn the science of government by consent! President Trump said; *“In America, the people govern, the people rule, and the people are sovereign. I was elected not to take power, but to give power to the American people, where it belongs.”*

The problem Mr. President, is that the People don’t understand what being sovereign is; they don’t know how to govern or rule; in short, they don’t know how to have government by consent! Whereas, Thomas Jefferson said, *“If a People expect to be ignorant and free they expect what never was and never will be!”* Without a proper education for the People, your work is in vain! Our courts have been hijacked by lawless men who have changed the Law of the Land to civil law which denies due process and enslaves the People.

Bar lawyers are taught that Grand juries are empowered by federal or state law and that a True Bill requires a prosecutor’s signature to verify a valid cause. Whereas, grand juries are an unalienable right empowered by God and not legislators. We the People only gave legislators power to legislate positive law, under the rules of “Natural Law in equity and not rewrite the Laws of nature’s God applied by the People alone, via juries. Quoting Antonin Scalia in *US v Williams*² we read,

“Recognizing the tradition of independence, we have said that the Fifth Amendment’s “constitutional guarantee presupposes an investigative body ‘acting

independently of either prosecuting attorney or judge. The constitutions of most of our states assert that all power is inherent in the people; that they may exercise it by themselves, in all cases to which they think themselves competent, as in electing their functionary's executive and legislative, and deciding by a jury of themselves, both fact and law, in all judiciary cases in which any fact is involved. The American grand jury is neither part of the judicial, executive nor legislative branches of government, but instead belongs to the people. It is in effect a fourth branch of government 'governed' and administered to directly by and on behalf of the American people, and its authority emanates from the Bill of Rights. Thus, [People] have the unbridled right to empanel their own grand juries and present 'True Bills' of indictment to a court, which is then required to commence a criminal proceeding." Our Founding Fathers presciently thereby created a 'buffer' the people may rely upon for 'justice,' when public officials, including judges, criminally violate the law."

The People thereby having the unbridled right to empanel and preside over their own proceedings unfettered by technical rules and to investigate merely on suspicion. It is the Grand Jury's function to consider criminal charges not prosecutors which have no authority to change or negotiate away the Grand Jury's indictments. Indictments are final and any additional charges cannot be added without the consent of the grand jury. But the BAR and thereby its minions ignore the Law of the Land and do what they please!

Bar lawyers are also taught that Common law is deeply rooted in the principle of stare decisis where courts follow precedents established by previous decisions, where the presiding judge determines which precedents to apply in deciding each new case. This repugnant principle is both self-serving and a lie. Whereas, Common Law, aka Natural Law is God's Law written in the hearts of men and not self-serving legislators and BAR judges. God's Law is simply common-sense applying judgment from the heart with an eye on justice and the consideration of mercy. Statutes, precedents and BAR taught judges are incapable of applying Common Law and that's why properly orientated juries as confirmed by Justice Antonin Scalia are the sole deciders of the facts, law, and penalties. All of which have been stolen from the People by the BAR and all its minions.

The UUSCLGJ has filed 252 filings on behalf of 252 people and 99 Indictments all of which have been ignored! This is the epitome of proof of a conspiracy. We have also served two Presentments to the United States Supreme Court but their clerks, probably under the direction of a judge, removed and returned them in violation of 18 USC § 2071 and 18 USC §2076. Whereas, this Presentment to SCOTUS has been directed to Chief Court Clerk Scott S. Harris and the Grand Jury has decided on inditements for anyone who violates said codes.

If 250 years has taught us anything, it is that if government is in control of our education, they will never teach the People they are sovereign and how to have government by consent. President Trump took the first step by shutting down the department of education thereby ending "centralized outcome-based education." The necessary second step is that it is up to the People to take control of their local school boards and require a proper education. Again, the problem is that the People don't know how to take control of their school boards nor do they

know what a proper education is and they are not organized at the grassroots to accomplish such a goal. Therein is NLA's mission.
