

# AGREEMENT

**IT IS UNDERSTOOD THAT:** Many members of NLA, including Coordinators, may not choose to become Administrators but are willing to take on leadership and other supporting roles in order to work together to save our Nation by bringing control of our government back to the People through Courts of Justice.

Until We the People take our lawful seat in our courts as Administrators and Jurist We the People under the leadership of NLA will from time to time perform extraordinary acts as "Unified" State and United States Common Law Grand Juries writing "True Bills" designed to educate, inform and enforce the Law of the Land.

NLA's research has concluded that there is just one way to achieve and retain our goal, and until we the People are seated in the courthouse all NLA Coordinators and Administrators herein agree that they will follow the NLA plan to seat the People. We expect anyone that takes a leadership role to follow our protocols. If you have ideas that may help our cause bring them to our Monday night open forum for consideration.

It is presently perceived that within thirty to ninety days after the People are rightfully seated the need of our performance as "Unified Juries" will become a rare necessity. But in order to get to that point we need to follow historic judicial procedures and principles. Over the past 18 months we have had numerous people who with haphazard thinking tried to move NLA off point in order to thwart our plan to initiate another. Fictional procedures and expedience will only yield failure. Therefore all state meetings must adhere to strict protocols with a focus on the following:

- 1) Advancement of the latest updated events and agendas from our National meetings
- 2) Encourage all participants to join our national Monday night call
- 3) Encourage all participants to enroll in our civics course
- 4) Encourage all participants to support NLA
- 5) Organizing your state county by county
- 6) Build your membership by bringing NLA's message to Liberty Groups throughout your state
- 7) Exercise the principles necessary to achieve and maintain our goals such as honor justice and mercy
- 8) Meetings should be 15-30 minutes and should not discuss non NLA subject matter
- 9) All meetings must be hosted by a Coordinator, no exceptions

People are certainly free to believe and practice whatever they wish but the purpose of our state meetings and use of our mailing lists are not to advance personal agendas that will bring the NLA

plan off course. Anyone found doing so will be removed from NLA's membership.

The power of the Grand Jury is to write and file true bills with the assistance of the Grand Jury Administrators. All Administrations, upon their own will, from all counties are not to write any papers until we are seated in our courthouses and complete the following NLA's courses:

- 1) Civics course
- 2) Administration
- 3) How to structure and write True Bills
- 4) Jury orientation
- 5) Filing system
- 6) Rule by principles
- 7) Constitutional Powers

The power and authority of the Common Law Grand Jury Administration is to:

- (1) Investigate;
- (2) Negotiate a remedy between the violator and the injured party;
- (3) Bring the issue before the Grand Jury chosen from a pool within the county or federal district.

The power and authority of the Common Law Grand Jury is to write and file with the Court of Jurisdiction:

- (1) True Bill of Indictment,
- (2) True Bill of Presentment,
- (3) True Bill of Information, and
- (4) In extraordinary cases writs from the king's bench

As to depending upon by what authority we act, we are to identify ourselves as:

- (1) The People
- (2) Common Law Grand Jury (only upon true bills and summonses)
- (3) Common Law Grand Jury Administrators

We shall never identify ourselves as sovereign citizens, of the soil, of the flesh or any other identity that endeavors to escape the jurisdiction of the fiction, nor will we refuse to pass the bar for by doing these things we acknowledge the legality of the fraud and thereby empower them.

The Grand Jury or its Administration does not have the authority to:

- (1) File any papers outside the aforesaid,
- (2) Enforce a judgment without due process (due process is a trial by jury in a court of law),
- (3) File commercial liens,
- (4) Threaten and intimidate,
- (5) Write bills of exchange, redeeming and/or discharging through trust accounts,
- (6) Engage in commercial contracts,

- (7) File commercial liens,
- (8) Exchange an oath of office for a value.

*“we have insisted that the grand jury remain "free to pursue its investigations unhindered by external influence or supervision so long as it does not trench upon the legitimate rights of any witness called before it." United States v. Dionisio, 410 U.S. 1, 17-18, 93 S.Ct. 764, 773, 35 L.Ed.2d 67 (1973).*

The Grand Jury administration is not judge, trier and executioner, that’s the role of a tyrant.

NLA is only a facilitator of knowledge, organization and communications. We have no chief but God, we will either stand on principles or we will kiss the boots of tyrants. When the People take their proper seat in the courthouses and are sufficiently educated as to their principles and duties NLA promises that the people will increase and NLA will decrease, after which NLA will continue as facilitator for the following:

- 1) Provide an education for administrators,
- 2) Provide a mandatory civics course for all oath takers,
- 3) Provide an education for the People,
- 4) Provide communications between the states,
- 5) Provide advisors,
- 6) Provide court watchers,
- 7) Provide a national phone directory for all 3134 county Common Law Grand Jury Administrators,
- 8) Provide for the organization of People to produce statesmen in place of politicians,
- 9) Provide for the advancement of all of the above in our schools,
- 10) Provide national meetings for the advancement of all of the above.

By signing this agreement you agree to all of the above and if you are found in violation of this agreement you agree to forfeit your Leadership position and/or Administrator.
